Description of eventual changes since the last course instance

It was the first time this course was run. Due to the corona pandemic it was changed into a web-based course and this resulted in the following changes: online lectures, home assignments instead of seminars, and a home exam.

Strengths of the course according to the students

The overall impression is that the students were pleased with the course (37.5% gave the course 5/5, and 62.5% 4/5). Students felt that the topic was interesting and inspiring. Teachers were appreciated for their engagement in respective topic, the expertise they represented, and the support they provided to the students. The web-based version seems to have been working satisfactory. The possibility to watch recorded lectures later online and the teachers' efforts to activate students were appreciated.

Weaknesses of the course according to the students

Students wanted more feedback on home assignments, extended time for the home exam, improved instructions for the individual project, and more teachers from regulatory agencies.

Teachers analysis of course implementation

Overall the teachers found that the course worked well regarding the content, administration, and technical aspects. The teachers found it both challenging and inspiring to teach on a web-based course. The biggest challenges were to engage students in discussions during the lectures, and to create a home exam that reflected the course and gave students the opportunity to show what they learnt.

Conclusions and proposals for changes

The course was appreciated by both students and teachers. Based on the course evaluation and the course coordinators own ideas, the following changes are proposed for next year:


- Invite more teachers from regulatory agencies and organize a study visit.
- Make changes in the schedule that reflect the current "hot" topics within the regulation of chemicals.
- Add more seminars/home assignments to activate students and to improve understanding of the topic.
- Improve instructions for the individual project.
- Provide more individual feedback on the home assignments/seminars and the individual project.
- Extend the time for the home exam (if there will be a home exam).
























