This helped to enhance the quality of the learning process and produced the desired objective to provide quality education to both undergraduate and master students.

The academic seminars is a continuation of the group seminars with higher requirements for students to do further research to write a long thesis between 10 to 15 pages.

The group and academic seminars in which students take much ownership of their studies is well reflected in the final positive written examination results.




