


The purpose of PIL

Why study public international law?

- Today, public international law (PIL) is everywhere.
- Traditional PIL issues like armed conflict and diplomatic relations, but also
 - the international economy, from trade to financing to development
 - the rights and responsibilities of individuals (human rights, international criminal law)
 - environmental issues (including climate change)
 - anything that states see fit to regulate....
- PIL reaches deep into the daily governance of states, municipalities, corporations and individuals.
- Challenges: Non-state actors, new technologies, economic globalisation, transnational risks (from climate change to crime to pandemics).



Why should you apply to our programme?

- Because public international law is the bedrock of international relations <u>and</u> an important factor in domestic life
- Because you want an international career in public service, in private practice, as a scholar or as an advocate
- Because theory and practice are intimately related, and because a good theoretical understanding will help you understand the changes in law
