
Concept of the EEL programme

Content of the EEL programme

- Advanced European Economic Law (15 ECTS), devoted to issues
 of constitutional and methodological character.
- Elective specialisation course (15 ECTS)
 - Allow students to expand their knowledge in particular subjects of EEL and their relevant methodologies
 - EU Competition Law, or
 - The Digital Internal Market and its Social Dimension, or
 - EU Banking and Financial Law.
- Legal Methods in Research and Practice (15 ECTS)
 - Students develop skills in applying European legal methods through participating in a EU Moot Court and through interactive seminars and research workshops.
- The programme concludes with a Master thesis on a selected topic of EEL (15 ECTS).



Programme approach

- The programme builds on:
 - A close-knit group of master students
 - Accessible teaching staff
 - Variety of learning formats
 - Emphasis on active student participation
 - Social and extra-curriculum activities

Alumni network

- comprises a large number of academics and practitioners, many of them having prominent positions at European institutions such as the ECJ, the Commission, Swedish and foreign universities, public agencies like the Swedish Competition Agency and Swedish National Board of Trade and leading law firms across the continent.
- Three judges at the European Court of Justice or the General Court have been lecturers at Stockholm University, and two Judges are former LL.M. students. Few, if any, LLM programmes have so many alumni in the current colloquium of CJEU judges.
