## **1. Literature**

## **2. Reading instructions**

As always when studying law, reading is essential and the written word a main source of information. Finding the appropriate reading material is part of your studying and it is your responsibility.

## **3. Teaching**

The course potentially consists of two basic learning activities: (1) Research seminars, where the researcher provides the discussion and insights for an area of law and (2) seminars and opposition seminar / conference, where you are expected to take active part in the discussions.

At the end of the Course there will be a LLM Conference where the students shall present their theses.

### **Research seminars**

Preferably, you will have read the text and material indicated in the reading instructions prior to the lectures so that you may take part in the discussions. You are welcome to ask for clarifications and to raise additional questions at the lectures.

### **Seminars**

Seminars may be offered to the LL.M students, regarding methodology and essay writing. There will also be seminars where students have to discuss in groups important questions for their thesis such as defining relevant questions, delimiting the research questions, methodological considerations, critical management and use of source material, and proper citation of sources, the student will thus discuss another student's thesis, by raising questions about the material presented or adding relevant information. These seminars will take place on the behalf of the supervisors.

### **Opposition seminar/ Student conference**

The **opposition seminar** will take place on the **20 May 2024**, where the students have to discuss and comment on important questions for their theses such as defining relevant questions, delimiting the research questions, methodological considerations, critical management and use of source material, and proper citation of sources, the student will thus orally "oppose" another student's thesis, by raising questions about the material presented or adding relevant information.

The draft theses should be handed in by **13 May 2024 at 12:00**.

The process is called the "opposition" process in Swedish legal education but it corresponds to the role of discussant in professional legal education and professional life throughout Europe. This "opposition" is to take approx. 20 minutes. The thesis discussed will cover a different topic than the one that has been written by the discussant.

All intended learning outcomes are assessed and measured on the basis of the individual thesis

(including the opposition, i.e. review of a thesis written by a peer). The thesis is a formative form of examination as it also constitutes a learning outcome.

Student conference where the students will present their theses will take place around or at the date of graduation.
