

# **Course Report for the Optional Course Cyber Law (JU668A, JU668B), 15hp, Spring Term 2023**

## **About This Course Report**

This course report follows the rector's template for course reports (Dnr SU FV 1.1.2-34-20). The course report is a compilation of the students' views on the course that emerged through the course evaluation (see appendix) as well as the teachers' views.

## **About the Course Evaluation**

The course evaluation was answered by 8 students out of a possible 28, (which amounts to a 29% rate of answer).

## **Description of Eventual Changes and Decisions Taken Since the Last Time the Course Was Given**

The number of mandatory seminars was reduced from five to four. This was done in order to enable the students to focus better on each individual seminar and allowing for adequate time between seminars. It also allowed for more time to be dedicated to the writing of the course essay.

The list of relevant reading was updated so as to include articles that were up-to-date and relevant in relation to current technological and legal developments.

External teachers were also chosen depending on the latest technological and legal developments. Also, considering the positive attitude to visiting law firms and other external actors, more visits were arranged.

Finally, the focus of one of the seminars was updated to reflect the increased relevance of Intellectual Property Law in relation to the general theme of the course.

## **Strengths of the Course Based on the Opinion of Students (summary based on quantitative results, free text answers and any other evaluation during the course)**

The quantitative results of the course evaluation show that an overwhelming majority of students were positive towards the course to the extent that it matched their expectations (63% matched expectations, 25% exceeded expectations and 13% greatly exceeded expectations). It was also generally easy or very easy for students to know what was expected of them.

It follows from the free text responses that the general theme of the course is appreciated to the extent that it mirrors current technical developments taking place in society. In additions, the visits to law firms were once again highly appreciated. It also follows from the

free text responses of the course evaluation that the students were satisfied with the teacher's efforts. The format of the course was appreciated to the extent that the course essay provides the students an opportunity to delve deeper into an area of law that they regarded as interesting during the lecture phase of the course. The examination format was also appreciated to the extent that it promoted self-learning as well as an opportunity to sharpen the writing skills of students.

**Weaknesses of the Course (summary based on quantitative results, free text answers and any other evaluation during the course)**

Based on free text answers, a minor criticism of the course was that the seminars were not graded and that the only gradable activity of the course was the course essay. For the sake of clarity, the seminars are in fact graded, although no points are awarded and the grade is only "pass" or "fail". In addition, the final grade is in fact made up of the actual essay as well as the opposition of the essay, so in theory there are more than just one gradable activity. Some lectures were considered repetitive; however, this is not necessarily negative where the materia is complex.

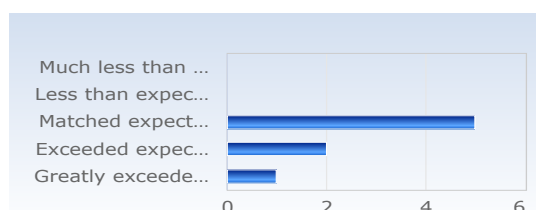
The course director and the rest of the teaching team are satisfied with the implementation of the course.

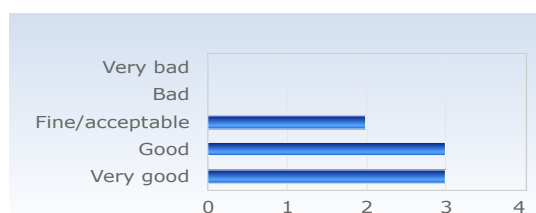

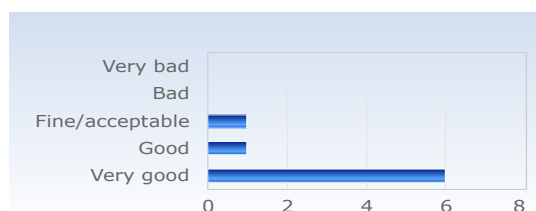

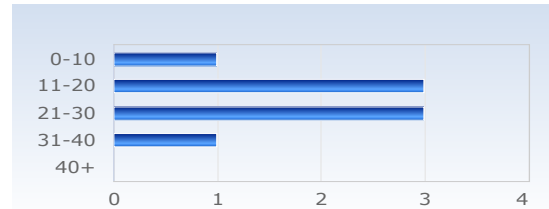

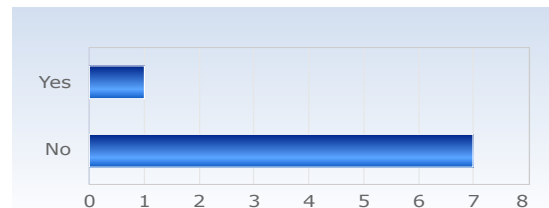

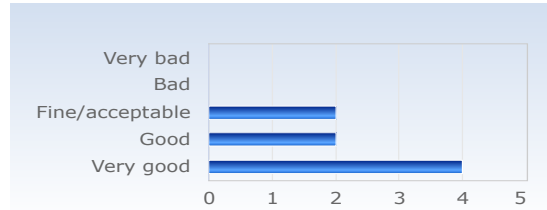

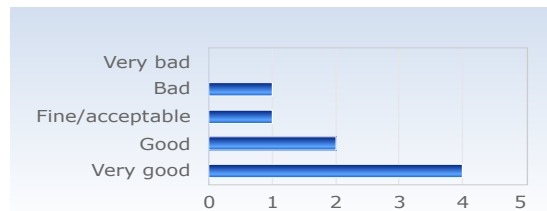

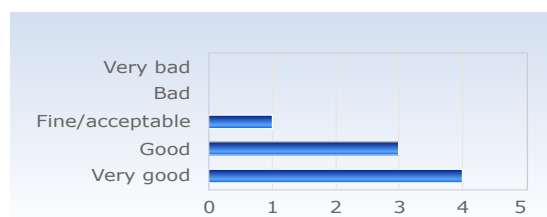

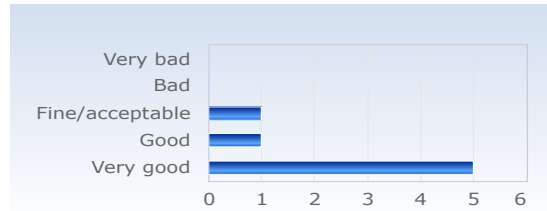

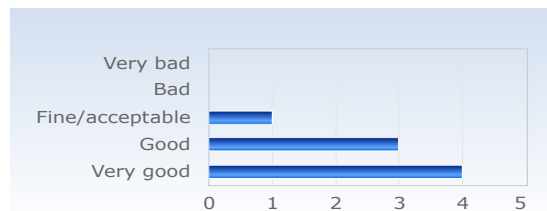


### Comment
